<u>Site Description</u>: Rush Pond/Recreation Area, in Queensbury, NY contains 3 miles of trails one way. The preserve is considered an Oak-Pine Eastern Adirondack Forest with interspersed segments of hemlock trees. This trail is a highly used multipurpose trail for hikers, runners and skiers alike.

Rush Pond is a freshwater pond and class II wetland. The pond is approximately 46 acres and the wetland is 81.3 acres. The waterbody substrate is comprised of muck with a bottom cover of macrophytes, leaf pack, and woody debris.

Survey Techniques: Survey was completed for both terrestrial and aquatic invasive species. Terrestrial species were detected along the trail while a shoreline survey was complete for aquatic invasive species when access to the pond was possible.

Did you identify this site through the iMapInvasives Prioritization Model? Yes, an area nearby scores very high for both ecological and comprehensive value and the pond trail is rated medium-high.
